

Outline of financial situation

- Expected end of 2025 year funds (if all modified 2025 budget spent): 700k CHF
- To note this would have been only 511k CHF without self re-budgeting of WCRP activities in 2025: Thank you!
- For 2025 can't yet give an accurate "expenditure to date" as new WMO finance system not yet fully operational.

- Although it is not 100% clear that we will lose the USGCRP (NSF) funding (though highly likely) or that the WMO funding will be reduced (or by how much) we have to take a cautionary approach. We will not know about these until the September/October timeframe. Additional funding avenues will also take time to materialize.
- Finance committee therefore decided to allocated based on the worse-case scenario but also including use of some our remaining predicted reserve.

- Minimized as far as possible expenses not allocated to science i.e., no in person JSC meeting, minimal JSC travel, almost no WCRP secretariat travel, no secretariat training or equipment, minimal comms (essential software only), minimal additional staffing (website maintenance only), and only committed expenses for e.g., GCOS.
- Finance committee suggestion to allocate rest of income (307k) plus 163k of reserve leaving 470k CHF to be allocated.

Means roughly 38% of activity requests could be funded









Principles for assessing 2026 budget proposals

- All activities have lost funding (generally around 2/3rds), and JSC agree to contingency (reserve) funds for 2026
- Initial allocation was \$40K per CP and \$15K per LHA with final adjustments to allow for priorities below
- Essential travel only (such as first time F2F meeting, milestone assembly, OSC/Assembly etc, ECR)
- Some level of training and ECR capacity-building to be maintained
- Priority cross WCRP initiatives and assessments to be supported (Tipping Point Assessment, TCRE, Mountain hydroclimate)
- Major 1 in 4 year Assemblies, OSCs to be supported
- Activities should be encouraged to raise additional funds
- Activities to provide feedback on the first draft budget allocations and then internally decide on how to allocate their own budgets taking JSC guidance into account
- Plan for the global south fellowship
