Minutes

Gutowski chaired the meeting. He went through the agenda and asked if there were additions to it. Goodess proposed the following topics:

- 6th International Conference on Climate Services (ICCS6) in Pune a status update
- Next steps and next telecon for the TTRA

Agenda topic 1. Revamping the WGRC into a new Working Group on Information for Regions (WGIR)

Two discussion notes were distributed to the TT the week prior to the telecon:

- Goals and Terms of Reference of a new Working Group on Information for Regions (WGIR)
- Reflections on the membership for the WGIR.

After the discussion of the Terms of Reference the TTRA arrived to the following consensus:

- The WGIR is proposed as mechanism for the achievement of objective 4 (*Bridging Science with Society*) by pulling together WCRP efforts that produce information for regions, identifying scientific challenges and needs of regional climates, and providing an interface with climate services.
- CORA should not become an IPO for WGIR, although it should have a close link to WGIR. CORA has a strong operational modality and its role shall remain as originally envisioned: a resource across all WCRP bodies regarding regional activities and thus the CORA's ToR will not be changed.
- A key element for the success of WGIR is to ensure that communications and gathering of the information for regions is achieved across all elements of the future WCRP in a matrix style, e.g. both horizontally and cross-cutting. The TTRA is encouraged to use the Implementation Plan Framework to re-think and shape the communications.
- The TTRA is asked to revise and comment the tentative ToR, although it was agreed not to dwell further into details on WGIRs' implementation until the outcomes of the upcoming WCRP workshops scientific Questions" and "Elements and Structures", are known,

Actions:

- The TTRA is asked to revise and comment on WGIR Terms of Reference by February 24. The

Agenda topic 3: Work Plan
