

## 1. Founding principles

We spent a significant time in our first meeting discussing and developing our founding principles since this is vital for our future plans.

We **do** see the key role of the Academy as a facilitator, both broadening the access to training for those who need it and identifying needs for training and encouraging providers to match needs

We do not see the Academy as having an external, 'outreach' role.

We do not see the Academy as a training provider

#### 2. Partners – external and internal to WCRP

This is the least well developed so far. Key partners include:

- WCRP Core Projects (discussed in SPARC SSG only, but team members from all key projects)
- WMO (discussed with Patrick Parrish, ETR)

#### To Do:

- FutureEarth
- Funders/Philanthropy

Key point: Need to have clear sense of objectives first

2. Who are the critical Partners?

- Have they been contacted, and are they being engaged in the co-design?
- NB this includes those external (e.g. Future Earth) and internal to WCRP (esp. the Core Projects).











## 3. Resource requirements – needs now

The support we have had so far from Narelle to set up the team and arrange first meetings etc. has been fantastic (thanks Narelle!). Please can we keep Narelle?

#### Needs now:

- 1. Professional help for design, distribution and data collection for stock-take survey
- 2. Establishment of Academy website and development of name/logo/identity (web and/or graphic designer, hosting)

# 3. Resource requirements – long-term

#### In the long-term:

- Academy needs a small full-time staff, business plan in development
- 2. The two centre pieces of the Academy (the portal and the annual stock-take) need long-term funding
- 3. Seed funding to develop training where this is not currently provided will help to ensure a well functioning marketplace








## 4. Draft Timeline and Roadmap: Science Plans and LHA Launch

# 4. Working Groups

#### Stock-take

Aim: Design mechanism to understand what training is available and what is needed.

Long-term: How to operationalize this function.

#### **Identity and portal**

Aim: Establish valueproposition and brand

Develop web-portal

Long-term: Guides development of platform

#### **Finance**

Aim: Establish business model

Build proposal and options

Long-term: Financial sustainability and mechanisms
